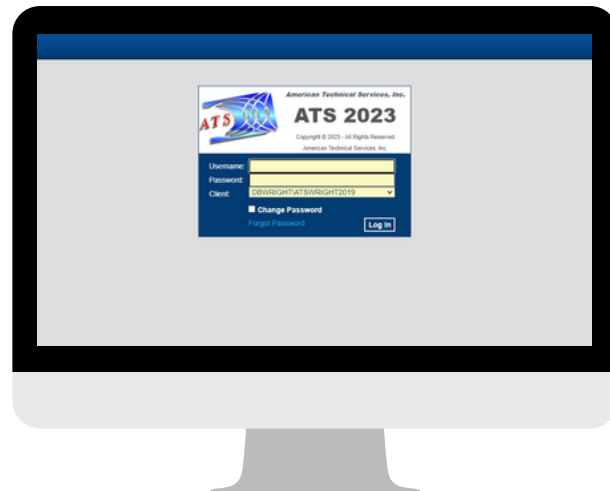


Workers' Comp Claim Reporting Portal User Guide



Overview

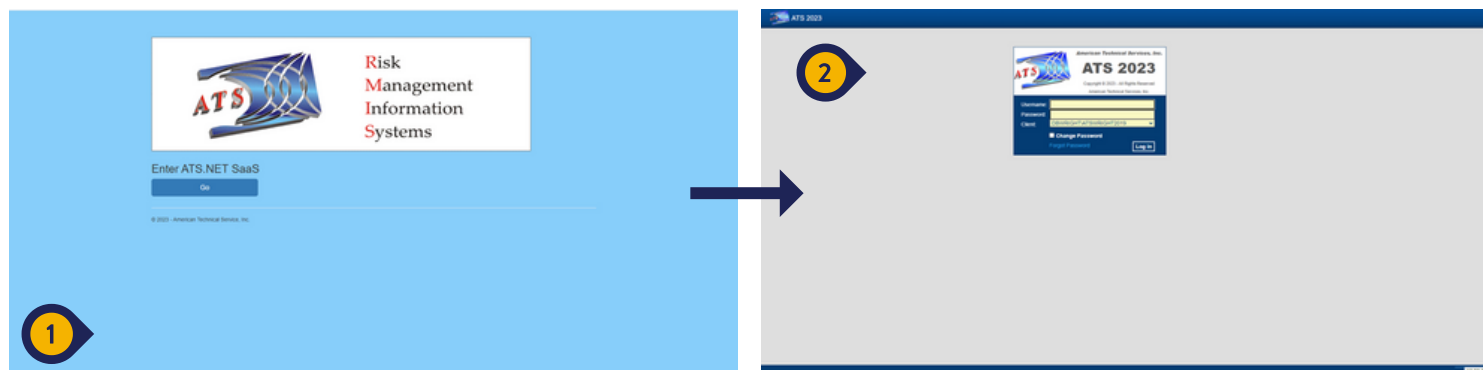
The External Reporting Portal provides registered users with access to the ATS system. The system will allow you to do the following:

- Enter First Report of Injury (FROI)
- Print the NY Workers' Compensation Board Employer's First Report of Work-Related Injury/Illness (C2-F)
 - A copy will be emailed to the user upon submission of the claim
- Upload additional supporting documentation to the claim
- Instantly receive a claim number
- View claim details and financials

Logging In

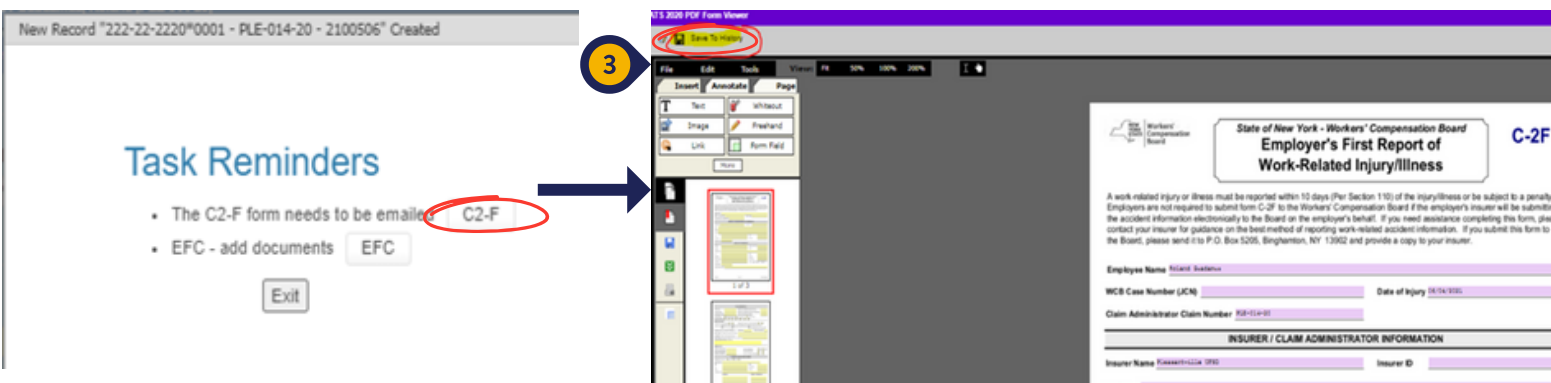
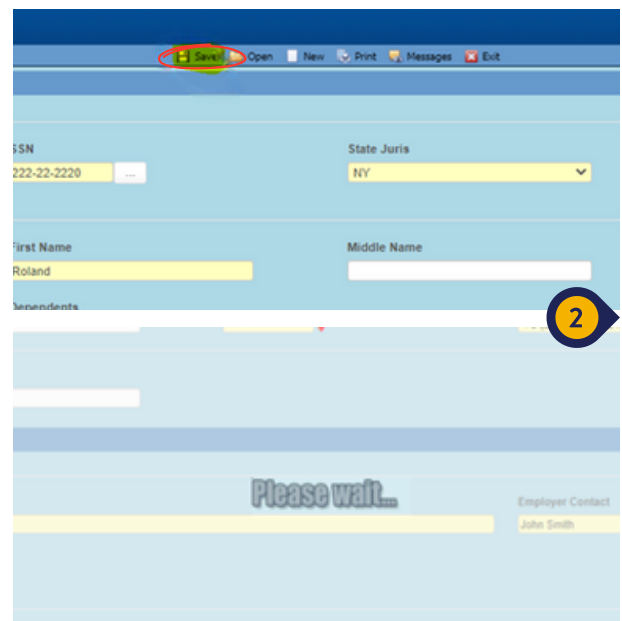
Log into the system using the credentials provided by Wright Risk Management at: <https://wright.atrsmis.com/>

1. When the page loads, **click on Go**.
2. You will then be prompted to **enter your credentials**.



Creating a Report

1. After logging in successfully, you will arrive at the ATS Console Page, displaying the Recently Accessed claims and the Workers' Compensation Menu. On the Workers' Compensation Menu, **click on First Reports, and select New FROI.**
2. The data entry screen appears. Enter the data about the injury on the screen. **All fields highlighted in yellow are required fields.** You are not required to fill out fields that are not highlighted, but it is helpful to WRM. Once you have filled out all pertinent data fields, **click the Save icon** at the top of the screen. The page will display the words "Please Wait..."
3. After saving successfully, the screen will display Task Reminders. **Click on the C2-F button** to display or modify the C2-F form. The form will be displayed on the screen, allowing you to modify it if you need to. When the form looks complete, **click on the Save To History button** on the upper right.



Saving

1. A popup will display, allowing you to rename the document as you wish. This is how the document is saved in the system. **Click Save To History again.**
2. After clicking Save To History, **you'll see a confirmation window** showing that the document was saved. In the background, the system will email you the form and a copy will be sent to WRM.

Adding Additional Documents

1. To add additional documents, **click on the EFC button** under Task Reminders. The Electronic File Cabinet (EFC) page will open.
2. **Click on the 'Add Document(s)' button.** Upload the document and give it a description. **Click Save.**
3. To view the documents, **click on the link in the Doc ID column.** Close out of the EFC and you'll return to the Task Reminders page. Click Exit when done.
